VESS Scientific Program at SVS/ VAM

We had another successful Spring Meeting in Boston this past June. The VESS Program Committee under the leadership of **Dr. Murray Shames**, selected outstanding abstracts for presentation on June 4, 2014.

Following the success of the past few years' scientific program, the VESS Program Committee partnered with the Society for Vascular Surgery Program Committee to review all of the abstracts submitted to the Vascular Annual Meeting. With the unbiased leadership of **Dr. Ron Fairman** the selection process identified 27 abstracts that reflect the broad scope of practice of the VESS membership.

The 2014 VESS Spring Meeting highlighted exciting clinical research from more than 20 Vascular Surgery Programs in the USA as well as from a number of International Programs. Topics of discussion at the VESS Spring Meeting included management of thoracic aortic pathology, selection criteria for REVAR, stroke after CEA, criteria impacting readmission after vascular surgery procedures and factors impacting the cost of healthcare delivery. The program also included discussions on the use of robotics and simulation in vascular surgery, lessons learned developing a complex fenestrated program as well as data from multicenter trials looking at the management of lower extremity interventions for peripheral vascular disease. Finally, management strategies for complications of hemodialysis access, the diagnosis and treatment of Thoracic Outlet Syndrome, as well as the natural history of renal-artery aneurysms were presented. We also had the honor of introducing the winner of the Norman Rich Military Vascular Surgery Award, Cpt. Daniel Scott, MD from San Antonio Military Medical Center

We would like to thank the members of the VESS Program Committee for helping put together an outstanding scientific program for our Spring Meeting.

FVI/VESS Announces 2014 Young Faculty Award Winner

Dr. Coleman's project "Efficacy of Apixiban in Anti-Inflammatory Indused Vein Wall Remodeling in A Murine Model Of Deep Vein Thrombosis" was chosen amongst many spectacular applications that were received this year. The committee considered several criteria points including the applicant, the strength and scope of the science within the application, innovation and the research environment. The Award provides \$12,500 in research funding.

Why Young Vascular Surgeons Should Join VESS

The Vascular and Endovascular Surgery Society (VESS) is a national society that targets the young vascular surgeon. Formerly known as the Peripheral Vascular Surgery Society (PVSS), this Society has two national meetings each year: a winter meeting in Colorado or Utah and a spring meeting in conjunction with the VAM. The Society encourages participation with an atmosphere that is more relaxed than other national forums. At my first PVSS meeting several months after finishing fellowship, I went to the microphone and asked a question to the presenter with significant trepidation. A robust discussion ensued and I immediately felt part of the Society. I joined and have served on multiple committees throughout the next decade.

Why should the young vascular surgeon join the VESS? I can think of several reasons. First, it allows people just out of their fellowship to be part of a national society. They may attend the meetings, participate in the discussions, and ask questions in a comfortable environment. Over the last several years, the committee structure has been greatly expanded. This allows for larger participation in the governance of the Society. Many of the roles progress to committee chair designation and service on the executive council. Experience with this is invaluable to individuals who want to play a part in other societies and advance their academic careers.

Second, programs have been created that pair trainees with practicing vascular surgeons to support these individuals in career development and provide a fresh perspective from someone who has gone down a similar road. In recent years, the Society has focused on inclusion of residents and medical students in addition to fresh graduates from vascular surgery fellowship programs. At the winter meeting this past year, a separate session was added for trainee education in practice management as well as a hands-on session with industry and members of the VESS executive council to review endovascular products from multiple vendors.

Third, the plenary sessions are a relaxed environment to present data on the podium. The discussions are robust and the data is submitted from the winter meeting to the Annals of Vascular Surgery and from the spring meeting to the Journal of Vascular Surgery.



VESS announces the VESS Regional Ambassadors Program


The VESS Regional Ambassador program was established to facilitate outreach across the country and across the entire specialty. By assigning regional representatives, we will be able to effectively communicate to the existing membership, directly recruit new members to the society – both candidate and full members, and encourage senior members to stay engaged with society activities. This comprehensive network of communication will greatly enhance the impact of VESS initiatives through increased participation in society programs.
